

If the product is potted in costumer applications, the potting material might shrink during and after hardening. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Follow all instructions mentioned in the data sheet, especially:

- The soldering profile has to be complied with according to the technical reflow soldering specification, otherwise this will void the
 warranty
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't
 be enough.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- Solvents may influence the product marking.
